

RURAL MUNICIPALITY OF ENTERPRISE NO. 142

BYLAW NO. 01-2021

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR THE PURPOSE OF FURTHER DEVELOPING AND MAINTAINING TH REGIONAL PARK KNOWN AS MCLAREN LAKE REGIONAL PARK BETWEEN THE RURAL MUNICIPALITY OF ENTERPRISE NO. 142, THE VILLAGE OF RICHMOUND AND THE MCLAREN LAKE REGIONAL PARK.

The council of The Rural Municipality of Enterprise No. 142 in the Province of Saskatchewan, enacts as follows:

1. The R.M. of Enterprise No. 142 is hereby authorized to enter into an agreement with The Village of Richmond and the McLaren Lake Regional Park Authority, the terms of which are attached hereto and marked as Exhibit 'A' for the purpose of further developing and maintaining McLaren Lake Regional Park.
2. The Reeve and Administrator of the R.M. of Enterprise No. 142 are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit 'A'.
3. This bylaw shall come into force and take effect from and after the final passing thereof.
4. Bylaw No. 1-2000 is hereby repealed.

THIS AGREEMENT MADE BETWEEN:

McLAREN LAKE REGIONAL PARK AUTHORITY, a corporate body operating under the provisions of *The Regional Parks Act, 2013*,

-and-

THE RURAL MUNICIPALITY OF ENTERRPRISE No. 142, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "R.M. No. 142",

-and-

THE VILLAGE OF RICHMOUND, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "Village of Richmond".

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further developing and maintaining the regional park known as McLAREN LAKE REGIONAL PARK established under *The Regional Parks Act, 2013* and the parties wish to continue this agreement until otherwise advised. If any party wishes to remove themselves from this agreement it must be done in writing to all parties involved at least 90 days in advance.

The parties jointly agree to the following:

1. TO CONTINUE to associate and work together and appoint representative to McLAREN LAKE REGIONAL PARK AUTHORITY to further develop, operate and maintain McLAREN LAKE REGIONAL PARK. The municipalities shall appoint the following number of representatives to the Regional Park Authority pursuant to Section 9 of *The Regional Parks Act, 2013* and Section 5 of the Regulations:

R.M. No. 142	4 Representatives
Village of Richmond	3 Representatives
McLaren Lake	2 Representatives at large

2. TO CONTINUE to develop, operate and maintain the area of land designated as McLAREN LAKE REGIONAL PARK and more particularly described as follows:

all the portion of the North East Quarter of
Section TWENTY SIX (26),
In Township FIFTEEN (15),
In Range TWENTY NINE (29),

West of the Third Meridian, in the province of Saskatchewan, Canada, shown as Parcel 'A' on a Plan of Record in the Land Titles Office for Swift Current Land Registration District as No. 61-SC-11371. Subject to the mineral exceptions, reservations, and conditions contained in an instrument registered as No. DT 2481.

3. TO ADHERE to Section 20 of *The Regional Park Act, 2013* the Regional Park Authority shall submit the following reports on or before April 1 in each year to each municipality and organization represented on the regional park authority;
 - a. An annual report respecting operations of the regional park authority for the previous year and finances of the regional park authority as of December 31 of the previous year;
 - b. A copy of a report respecting all outstanding borrowings and current investments of the regional park authority as of December 31 of the previous year; and
 - c. The audited statement or the report on the review required pursuant to section 28 for the previous year.
4. THIS AGREEMENT shall remain in effect until it is repealed by a subsequent bylaw.
